Ziegler acquires shares of a manufacturer of aerial rescue platforms

Giengen (Germany), 1st February 2017 - The Albert Ziegler GmbH has acquired shares in the Italian manufacturer of aerial rescue platforms CELA Srl. based in Italy. The cooperation will be on the development, production and sales of aerial rescue platforms. Ziegler has bought 25 percent of CELA Srl.

At the beginning of the year, Ziegler has sealed the cooperation with CELA Srl. Through the cooperation, Ziegler is therefore able to expand its vehicle portfolio in the area of aerials and water towers, and creates a new market for high quality rescue stages mainly for the international market.



In the product range for fire rescue stages CELA designs and manufactures telescopic aerial platforms and water towers. With their innovative and technologically advanced solutions CELA is able to produce telescopic aerial platforms with a working height of 22 - 72 meters and water towers with a working height of 18 - 72 meters. In addition, special vehicles can be developed on customer request. At the manufacturing site in Corte Franca (Brescia) in Northern Italy CELA produces about 300 vehicles per year with 70 employees so far mainly for the industrial use.
